



## Player Registration Policy

When accepting a place on an advanced team, the player is committing to the Club for an entire seasonal year. The seasonal year extends from August 1 of a given calendar year to July 31 of the following calendar year. For U11 through U14 this means both fall and spring seasons. For U15 through U18 this means one season only due to high school play in the opposite season.

**CYS Rule 3.8 states:** *“When a team roster, as submitted by the club registrar, has been approved by CYS, each player registered to the team is bound to one of the club’s teams for the entire seasonal year (unless the player transfers to another club’s team or unless the player is dropped as provided below).”*

**CYS Rule 3.14 states:** *“The club to which a player is currently registered shall have sole discretion of whether to grant a transfer to that player as players are bound to their clubs for the entire seasonal year once registered. The decision of their club on whether to grant a requested release shall be final.”*

*“a. A player that has moved more than 50 miles from his primary residence shall be granted a transfer by CYS.”*

### GJSC Payment Policy

The payment plan is based on a seasonal soccer year as stated in the CYS rule 3.8. This will reflect the Club’s commitment to the player for the fall and spring seasons and the player’s commitment to the Club for both seasons. Once a player is registered (submission of the USYS form) the parent/legal guardian is responsible to meet the payment requirements as noted below for the appropriate age group.

#### U11 through U14

Payments will be due at the first of each month starting July 1<sup>st</sup>. A finance charge of 6% will be added to the balance of the account after 90 days from the registration meeting.

##### **\$100 Due at registration**

Monthly payments are due to the office on the 1<sup>st</sup> of each month.

#### U15 through U18

Girls Season- Payments will be due at the first of each month starting **July 1<sup>st</sup>**. A finance charge of 6% will be added to the balance of the account after 90 days from the registration meeting.

##### **\$100 Due at registration**

Monthly payments are due to the office on the 1<sup>st</sup> of each month.

Boys season- Payments will be due at the first of each month starting **December 1<sup>st</sup>**. A finance charge of 6% will be added to the balance of the account after 90 days from the registration meeting.

##### **\$100 Due at registration**

Monthly payments are due to the office on the 1<sup>st</sup> of each month.



### **Player Movement:**

Players may be added to teams to keep their numbers ideal throughout the season. All revisions to the team league roster must be submitted through the GJSC office that then forwards the information to CYS or WSSL. Advanced coaches must receive approval from the GJSC prior to revising their league roster. The reason for this is to justify the revisions according to other policies, procedures and club philosophies. It is also to insure correct administrative procedures are followed.

If a Premier team needs to revise their league roster during the season they should first look at players on the United team. They may also add a player that is not already on an Advanced team, if the coach strongly believes the player to be better than those players already on an Advanced team. The coach of the player who is requested to transfer onto the Premier team (or United team if transferring from a Inferno or Blaze team) will not in any way discourage or hinder the transfer.

When an Advanced team transfers a player off their team, they may replace that player at their discretion by utilizing the resources they have at their disposal according to GJSC and CYS policies and procedures.

The coach must obtain the affected player's and parents' agreement for the transfer.

All team fees to the old team must be current and paid to date this will release him from future debt to the old team. In turn he will incur all new fees from release date for the remaining seasonal year with the new team.

### **Player Transfer: (from club to club)**

A player seeking Transfer/Release from GJSC to another Club must submit in writing, signed by the parents/legal guardians, to the Board of Directors for GJSC. The request must include verification that all Club and team fees have been paid for the entire seasonal soccer year.

The Technical Director, Coaching Director and General Manager will consider the Transfer/Release request on case by case basis. The Transfer/Release will be approved only if in the opinion of The Director of Coaching, Coordinator of Advanced Program and the Director of Operations that this will not adversely affect the team, the age group, the Club and all fees have been paid. All requests will be decided within 3 to 10 business days, however the Club reserves the right to expand the process.

### **The Director of Coaching must approve the Transfer/Release.**

The cost of a Club to Club transfer shall be \$50.00.



### **Player Release: (drop)**

A player seeking Release from GJSC must submit a written request with an explanation of their reasons for the request, signed by the parents/legal guardians, to the Coach, The Technical Director, Coaching Director and General Manager. The request must include verification that all club and team fees have been paid for the entire seasonal soccer year.

Players that do not fulfill their commitment to their teams can negatively affect not only their team but also an entire age group within the Club. Players requesting Transfer/Release from the Club will be considered on an individual case basis.

The Release will only be approved if in the opinion of the Technical Director, Director of Coaching, General Manager, and the Coach feel that the Transfer/Release will not adversely affect the team, the age group, the Club, and all fees for the entire seasonal year have been paid. All requests will be decided within 3 to 10 business days, however the Club reserves the right to expand the process.

If approved, the Transfer/Release form will be signed by the player, the parents, and the Technical Director (or General Manager in the Technical Directors absence).

### **Refund Policy (Advanced Program)**

#### **No refund of registration fees are allowed under any conditions, except:**

Written petitions by the parents/guardians to the GJSC Board for extenuating circumstances - at the GJSC Board's discretion.

If a player involuntarily leaves the Club for reasons such as a parent job transfer out of state or player injury, the player will qualify for the following refund of Club fees:

- Prior to the start of the season – Club fee will be refunded in full
- After the season begins and before the fourth game of the season – 50% of the Club fee will be refunded.
- After the fourth game – no refund will be made.

CYS Registration fees, Referee fees and Field fees are not refundable for either voluntary or involuntary departures
